The undersigned, having read the Contract Documents including the Notice to Bidders, Instruction to Bidders, all Specifications, Proposals, Contracts, Bonds, Plans, etc for the project located on Harris Harbor Drive in Carroll Township, Ottawa County, Ohio and likewise having inspected the site of the conditions affecting and governing the implementation of the said project hereby proposes to furnish all labor, materials, necessary tools, equipment, and all utility and transportation services necessary to complete in a workmanlike manner the Stormwater Pump Station Improvements for the Sand Beach Conservancy District for the following sums:

Accompanying this proposal is a valid bid bond in the amount of one hundred per cent (100%) of the bid, or a certified check, or bank cashier's check, in the amount of ten per cent (10%) of the total bid, payable to Sand Beach Conservancy District, which, it is agreed, will be forfeited to said Sand Beach Conservancy District if the undersigned fails to enter into a contract in conformity with the form of contract incorporated herein and furnish bonds as specified within fifteen (15) days after the contract is awarded to the undersigned.

In submitting this bid, it is understood that the Sand Beach Conservancy District reserves the right to reject any and all bids. It is agreed that this bid may not be withdrawn for thirty (30) days from the opening thereof.

We hereby declare that we will execute a formal contract with the Sand Beach Conservancy District according to the forms attached hereto and will furnish the required bonds within fifteen (15) days after a formal contract is delivered to the Sand Beach Conservancy District. We will begin construction within seven (7) days from the date said formal contract is delivered to the Sand Beach Conservancy District and will fully complete all work on or before March 31, 2013. We also hereby declare that we will not discriminate in any manner or form as to the hiring policies on account of race, sex, religion, or national origin.
